PAYMENT OF AND SECURITY FOR THE BONDS; ESTABLISHING A BOND
PAYMENT FUND FOR THE BONDS; AFFIRMING THE EXISTING SINKING
FUND; AUTHORIZING THE ACCEPTANCE OF THE BID OF THE PURCHASER
OF THE BONDS; AND REPEALING ANY INCONSISTENT ORDINANCES.
