1. **ORDINANCE 225-2026:**
AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP FOR THE CITY OF NICHOLASVILLE FROM A-1(COUNTY) TO R-1E (SINGLE FAMILY RESIDENTIAL DISTRICT) & R-1F (SINGLE FAMILY RESIDENTIAL DISTRICT) FOR APPROXIMATELY 53.35 ACRES OF PROPERTY LOCATED AT 2051 ASHGROVE ROAD (PVA PARCEL #067-00-00-016.00).

2. **ORDINANCE 226-2026:**
AN ORDINANCE AMENDING THE CITY OF NICHOLASVILLE PERSONNEL POLICIES AND PROCEDURES, COMPENSATION PLAN AND CLASSIFICATION PLAN. [This Ordinance amends the City of Nicholasville's Personnel Policies and Procedures: Compensation and Classification Plans by amending the minimum, middle and maximum salaries for each pay grade.]
3. **ORDINANCE 231-2026:**
AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF NICHOLASVILLE, KENTUCKY, TO REGULATE THE OPERATION OF ELECTRIC BICYCLES AND ELECTRIC SCOOTERS, ESTABLISH SAFETY REQUIREMENTS, PROVIDE OPERATIONAL STANDARDS FOR JUVENILES, RESTRICT USE IN CERTAIN PUBLIC AREAS, AND PROVIDE FOR ENFORCEMENT. [This Ordinance regulates the operation and use of electric bicycles and scooters, and establishes safety requirements and operational standards, restricts their use in certain public areas, and provides for enforcement of these rules.]
4. **ORDINANCE 232-2026:**
AN ORDINANCE AUTHORIZING THE OPERATION OF "STREET-LEGAL SPECIAL PURPOSE VEHICLES" AS DEFINED BY KRS CHAPTER 186 ON HIGHWAYS AND STREETS IN THE CITY OF NICHOLASVILLE AND ESTABLISHING RESTRICTIONS FOR OPERATION. [This Ordinance authorizes the operation of "Street Legal Special Purpose Vehicles" as defined by KRS Chapter 186 on highways and streets in the City of Nicholasville and establishes appropriate restrictions on such operation.]

5. **ORDINANCE 233-2026:**
AN ORDINANCE AMENDING THE CODE OF ORDINANCES FOR THE CITY OF NICHOLASVILLE PROHIBITING USE OF BICYCLES ON SIDEWALKS BY PERSONS OVER TWELVE YEARS OF AGE, EXCEPT AS OTHERWISE PERMITTED. [This Ordinance amends the Code of Ordinances of the City of Nicholasville, Kentucky to restrict the use of bicycles on sidewalks by persons over twelve (12) years of age, except as otherwise expressly permitted.]
